LLANBOIDY COMMUNITY COUNCIL MINUTES OF ORDINARY MEETING HELD ON

WEDNESDAY 9th OCTOBER 2024 AT 7.30 PM AT FRON FARM YURT RETREAT

Confirmation of minutes of meeting on 4th September.

The minutes of the meeting were **ACCEPTED** as a true record. Proposed by NT, seconded by OY.

Matters arising from September Minutes:

- a. a. Drive round the parish boundary date arranged: Friday 25th October at 4 p.m. car park Llanboidy CD,EJ, TL, BA, RW, BA, DP. 2 cars.
- b. Defibrillators. CD has emailed but has had no response to be followed up.

ACTION: CD to chase defibrillator purchase and training.

c. Street lights – CD has had no response as yet to the query about a possible new light at the top of the village. The previously not working light at the top of the village is now working as is the speed limit sign at the bottom of the village.

ACTION: CD to chase CCC re new light at top of village.

Declarations of Interest.

No new ones were identified by members.

1. Highways Update.

DP reported that the bridge at the bottom of the Sports and Social Club field has been protected by a temporary barrier and various. patches in tarmac have been done. There have been objections to the proposed yellow lines in the village and the decision is now with the CCC Cabinet members, with a decision likely in the autumn.

ACTION: DP to give update on decision at next meeting.

2. Planning.

Raise roofline by 1.2m, and add 2no. 1st floor windows. Add
external door opening and window to ground floor south
elevation. Replace UPVC windows and doors for new. Cottage
to rear of, Lamb Inn, Llanboidy, Whitland, SA34 0EL
Full planning permission. Conversion and re-use of
agricultural building to holiday let. Frowen, Cefnypant,
Whitland, SA34 0TP. Under Consultation.

These were noted. It was noted that BA had expressed a conflict of interest in the application for Frowen. No objections were noted.

3. Shared Prosperity Fund – update. Celebration/ Formal Opening of Play Area – to be rearranged. Fencing and grant application to Awards for All. Recovery of Losses from Zurich – re damaged slide.

Following the cancellation of the planned opening from September 30th due to bad weather, it was AGREED to rearrange the opening in the spring. CD reported that the Awards for All application is not

yet completed. Congratulations were given to to EJ for the successful application by Llanglydwen Community Association for an Awards for All grant of £20,000 for their play area.

Recovery of losses by Zurich Insurance Company: CD asked members to discuss the proposed recovery of losses for the claim for the damaged slide by Zurich. She had been asked to provide further details from DP and TL in order to process the claim but had not yet received this information from either party. DP and TL AGREED to provide the information and CD was mandated to respond to the loss adjusters accordingly.

ACTION: DP and TL to provide CD with the information requested and CD to liaise with the insurance company.

4. Accounts for First Six Months - Report Attached.

CD outlined the current position re income and expenditure and informed members that expenditure was only marginally higher than expected at this point in the year once expenditure covered by the grant was excluded.

5. Urdd Request for Grant support.

CD brought to the attention of members an appeal letter from the Urdd asking for suppoert for the local Eisteddfod next year. It was AGREED that this request was too late as all the Section 137 grant budgeted has been allocated. CD had also more recently received a request from Radio Glangwili also asking for money – again this was too late for this year and CD was asked to infrom both organisations to submit a formal grant application before April 1st next year. It was noted that the Urdd National Eisteddfod is to be held locally next year.

6. Tree Inspection Renewal Due November 2024

CD informed members that she had receeived an email from Tree Inspections Wales remindind the Council that a further inspection

was due this year. It was AGREED to get this done as members felt it was important.

ACTION: CD to arrange tree inspection.

Susan Evans reminded membes of the dead tree next to her house on the side of the road. It was AGREED this needed to be taken down. There was some discussion as to whether this was the responsibility of the landowner and it was AGREED to discuss it with Darren Phillips who owns the addjoining land. Various members volunteered to help with felling the tree and CD offered a copper beech sapling to replace it.

ACTION: Members to speak to Darren Phillips and assist with felling dead tree and planting replacement.

7. Training – Information Circulated.

CD reminded the members of the need to do training and drew attention to the information about courses she had circulated.

ACTION: All members to do appropriate training. Bursaries can be claimed.

8. Penback Farm and Llechclawdd and Planned Forestry Creation – update.

It was AGREED that the opportunity to take any action about Penback in particular had passed as it was too late and Penback is due to plant this autumn. It was AGREED that it was worth trying to get the rules changed still and that CD should write to the Senedd expressing the Council's concern about the ability of copmanies to afforest whole farms without planning permission being needed.

ACTION: CD to write to the Minister.

7. Correspondence.

CD outlined the correspondence received which was noted by members. SE and CD to write to express to the Local Government and Housing Committee of the Senedd enquiry to express concern about the accountability of, and unrealistic expectations on, small CCs and the burden on Clerks/ RFOs.

11. Super-fast broadband – updates.

DP reported that Voneus have pulled out of provision of superfast broadband to the area of Carmarthen West. BT Openreach are to be funded to do superfast broadband in this area instead.

12. AOB

RW: A young man in the village had collapsed and was ressuscitated by the postman recently.

DD: Asked about the Council's logo and CD apologised for not pursuing this further.

ACTION: CD to follow up the logo.

DP: Whitland have had a large grant to build an office for their Clerk from Ten Towns fund. CD was asked to write expressing

concern about this as Ten Towns funding was supposed to benefit the whole area of Whitland and its surroundings.

Sue Allen is asking for boundary changes between Whitland and Llanboidy around the Abbey. The County Council are conducting a review which will start in early December. A letter about this is to be expected.

Pontyfenni – there will be a meeting later in October to look at speed limits.

The stile at Sunnyhill will be done now the play area is finished. DP to ask BA if he can help with the fencing and if not to ask Peter Morris.

There is a New Footpaths Officer – Alex – who will be taking over from Jason Lawday. Dolwilym Bridge is open now.

CD: Cilymaenllwyd are holding a walk and formal opening of their footpaths on Saturday 19th October.
