- SECTION 14 ROAD TRAFFIC REGULATION ACT 1984 AS AMENDED BY THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991 – TEMPORARY ROAD CLOSURE – C3203 LLANBOIDY CARMARTHENSHIRE COUNTY COUNCIL HEREBY GIVES NOTICE that no person shall cause any vehicle to proceed along that length of road known as the C3203 Llanboidy, from a point 400 metres north-east of its junction with the C3215 for a distance of 150 metres in a north-easterly direction. The closure is necessary to ensure public safety whilst Openreach replace a pole, which shall take place on 5 th March 2026 from 08:00 to 18:00.
